



#### History of Bitcoin, digital GOLD:

Bitcoin is the work of a person or group of people hiding behind the pseudonym "Satoshi Nakamoto". He (or she) was able to converge different technologies combining cryptography and distributed registers in order to offer a value network without trusted third parties

In 2008, a certain Satoshi posted an article online describing the operation of a digital exchange system based on a new technology, the blockchain. What is exchanged on this system are not euros or dollars, but digital assets called bitcoins.

Bitcoin was created with the objective of competing with traditional currencies by giving citizens back control of their money via a decentralized alternative to traditional financial and monetary systems.

the main attraction of bitcoin lies elsewhere. More than an asset that can contribute to the diversification of a portfolio, many see it as protection against inflation, a real "digital gold"




